The income statistics above are reflected in US dollar amounts. Income is defined as commissions received from IT WORKS! and does not include income received from personal sales. "Active Distributor" is defined as a Distributor who earned at least one commission in 2022. Distributors who were inactive in 2022 did not earn commission in 2022, but had earned at least one commission prior to 2022 and had renewed their annual distributorship in 2022. The average monthly income for all Distributors (active and inactive) in 2022 was \$304. Out of all Distributors that signed up as Distributors since the beginning of 2022, 91% were still active at the end of the year. Months in Company is calculated by looking at every Distributor who made a new rank for the first time in 2022, and how long it took from enrollment date to date of first achieving that rank.

In 2022, 95.50% of all Distributors (active and inactive) received income from IT WORKS! and 4.50% of all Distributors received no income at all. Note that these figures do not represent a Distributor's profit, as they do not consider expenses incurred by a Distributor in operation or promotion of his/her business.
